2. Information We Collect

2.1 Information You Provide

- Account/Profile data: name, email, username, date of birth, optional photo/voice or demographic information you upload.
- Communications: messages you send us (support, feedback, surveys).
- Payment-related: we do not store full card numbers. Our processors receive card details; we may receive limited transaction metadata (date, amount, method, last four digits, country).

2.2 Information Collected Automatically

- **Usage data:** pages viewed, features used, session duration, clickstream, referring URLs.
- **Device/Browser data:** IP address, time zone, language, OS, device type/model, carrier/ISP, identifiers (e.g., advertising IDs such as IDFA/GAID).

• **Cookies/SDKs:** as explained in our Cookie Policy, used for essential functionality, analytics, and advertising personalization.

2.3 Sources

We obtain information from you, your devices, analytics providers (e.g., Google, Amplitude), marketing partners (e.g., ad networks, social platforms), and payment processors.

3. How We Use Information

We process information to:

- **Provide and secure** the Service, authenticate users, and fix errors;
- Operate subscriptions and process payments;
- Research, analyze, and improve the Service, including A/B tests, analytics, and product development;
- Customize experiences, available payment options, and offers (including Latin America localization and pricing);
- **Communicate** with you about the Service, updates, transactions, and policy changes;
- Send marketing messages (you can opt out any time);
- Personalize advertising with our partners subject to your choices;
- Enforce our Terms and prevent fraud, abuse, or security incidents;
- Comply with legal obligations.

4. Sharing of Information

We share information with:
